The parties undertake to take all necessary and reasonable measures to avoid corruption and bribery. Taking this to consideration:

- none of the parties will offer, promise or grant the other party, its employees or members
 of its management team, including their relatives or any third parties involved in the
 execution of the contract directly or indirectly, benefits or advantages (for example but not
 limited to amounts of money, gifts or invitations not related to business relations, such as
 invitations to sporting events, concerts, cultural events). Also, neither party will accept the
 offer, promise, receipt or granting in any other way of such benefits from a third party
 directly or indirectly involved in the execution of the contract.
- none of the parties will pay, authorize, offer, promise directly or through the Personnel employed to pay or any other material advantages resulting from or in connection with the Contract to civil servants, political parties, politicians, candidates for public offices;

- the parties will fulfill their tax obligations in accordance with the applicable legal provisions, and in accordance with the payment terms specified in the Contract.
- the parties confirm and warrant that they have implemented and will continue to implement policies and procedures to encourage compliance and compliance with applicable anti-corruption and anti-bribery laws and regulations.

Any breach of these obligations will result in the termination of the Agreement and entitle the aggrieved party to claim and receive damages.
